

Event Betting Rules

V.1.0 Last updated: August 10, 2021

I. Introduction

- 1. The Gaming Facility Operator shall submit the house rules to the Tribal Gaming Office ("TGO") prior to implementation. The TGO shall review the house rules and issue a written approval or disapproval of them. Any proposed changes to the house rules shall be approved by the TGO prior to implementation. The TGO shall make the house rules available to the Department upon request.
- 2. The house rules shall be conspicuously displayed in the event wagering area and on the event wagering platform.

II. Wagers

- 1. Types of wagers accepted;
 - a. Single-game bets ("Straight bets");
 - b. Teaser bets;
 - c. Parlays;
 - d. Over-under bets ("Totals");
 - e. Money line bets;
 - f. Spread bets;
 - g. Futures bets;
 - h. System bets ("Round Robin");
 - i. Pools;
 - j. Exchange wagering;
 - k. In-game wagering;
 - I. Team Proposition bets; and
 - m. Player Proposition bets.
- 2. Minimum wager will be \$1.00, and maximum event wager may not exceed \$5,000.00 at the point of sales window and \$3,000.00 at a kiosk; and payout may not exceed \$50,000.00.
- 3. Payment of winning event wagers will be made in cash after validation of ticket based on the odds and terms of the wager stated on the ticket.
- 4. All wagers placed at the kiosks or cashiers cage are to be made in cash. No player accounts will be set up or be made for use as an instrument for payment of wagers or receipt of winnings.

- 5. Wagers may only be accepted for posted terms.
- 6. Wagers for schedule changes and/or cancelled events will be refunded when ticket is redeemed.

III. Betting and Payout

- 1. Odds or proposition changes will be displayed on odds boards and kiosks at time of change.
- 2. Redeeming a winning event wager may be done at the cashier's cage, or via registered mail for tickets of less than \$600.00 in value.
- 3. For redemption of tickets of value over \$600.00 and odds greater than 300:1, identification will be required, and name will be checked against the state wide self-excluded list. Wagers claimed by self-excluded, casino- or tribal-excluded, or by other prohibited persons will be forfeited.
- 4. Lost or damaged tickets will not be reprinted or replaced.

IV. Errors

- 1. Incorrectly posted events, odds, or results will need to be brought to the attention of the casino and will be adjusted or remedied via the investigation process with the casino and TwinSpires.
- 2. Obvious errors on wagers will be investigated and corrected by the casino and TwinSpires at time of discovery and corrective action or payout then issued.

V. Disputes

- 1. Questions and complaints may be submitted to Mazatzal Casino. Patrons with a dispute will be directed to a member of Mazatzal Casino Management. Mazatzal Casino Management will make every reasonable effort to resolve disputes.
- 2. In case of a guest dispute, you may contact TGO for an independent investigation.
